Dear Chairman Cole and Ranking Member DeLauro:

I am requesting funding for Green Bay Austin Straubel Airport to acquire new Snow Removal Equipment. The entity to receive funding for this project is the Green Bay Austin Straubel International Airport, located at 2077 Airport Drive, Green Bay, Wisconsin, 54313.

The funding would be used to replace two plows and two brooms with two multifunction combination units, allowing GRB to be more efficient at snow removal operations. New SRE will improve the airport's ability to maintain safe and operational airfield conditions during winter weather events by increasing efficiency and reliability in snow and ice removal. Modern equipment provides enhanced plowing, sweeping, and blowing capabilities, allowing staff to clear runways, taxiways, and aprons more quickly and effectively while helping ensure continued compliance with FAA Part 139 requirements.

The project is an appropriate use of taxpayer funds because it increases the safety and efficiency of the GRB airport and benefits the tax-paying constituents who rely on the airport for travel, trade, and commerce.

The project has a federal nexus because the funding is federally authorized under 49 U.S.C. §§ 47101, 47102, and 47104. This project is consistent with federal goals for the development of safe and efficient airport operations. I certify that I have no financial interest in this project, and neither does anyone in my immediate family.
